RELEASE AGREEMENT

BY SIGNING THIS RELEASE, I AM GIVING UP MY RIGHT TO SUE THE HAMILTON FARM GOLF AND EQUESTRIAN CENTER, LLC, THE ELIZABETHTOWN WATER COMPANY, THE UNITED STATES EQUESTRIAN FEDERATION, THE BOROUGH OF PEAPACK AND GLADSTONE, THE AMERICAN DRIVING SOCIETY, THE UNITED STATES EQUESTRAIN TEAM FOUNDATION, LAND OWNERS AND THE GLADSTONE EQUESTRIAN ASSOCIATION, INC. THEIR OFFICIALS, DIRECTORS, EMPLOYEES OR AGENTS.
